NOTIFICATION ON PRIVACY FOR THE WEBSITE

This notification describes how personal data collected in compliance with Articles 13 and 14 of the GDPR 2016/679 are processed.

1) What PERSONAL INFORMATION do we collect?

Personal information collected may include: your contact information and information about personal characteristics, such as your nationality, addresses, residence etc..

2) PURPOSES OF DATA PROCESSING

Your data are processed for the following reasons: managing relations with the website's users and managing registration of the applications. No processing is undertaken on personal data that, in compliance with Art. 9 of the GDPR 2016/679, reveal an individual's racial or ethnic origins, political opinions, religious or philosophical beliefs or membership of a trade union, nor any genetic data, biometric data useable for the purpose of uniquely identifying a physical person, data about an individual's health, sex life or sexual orientation.

3) Nature of the PROVISION OF THE DATA

For the purposes of this notification, provision of the data is obligatory in order to be able to communicate with us.

4) Identity of the DATA CONTROLLER

5) PLACE OF PROCESSING

The data are processed by the Data Controller in its operative headquarters located in Corso Sempione 30.

6) RECIPIENTS OF THE DATA

The data are processed by staff specifically authorised and/or designated in writing to process the data (administrative staff), personnel employed for the purpose of managing our information systems, who may also undertake system administration functions and, in such cases, shall be appointed as such, and web management staff. 11) Lodging a COMPLAINT
